ACLU'S LAWSUIT DISMISSED

SANTA MONICA—Last year, the American Civil Liberties Union, along with the law firm of Munger, Tolles and Olson LLP, filed a lawsuit against the City of Santa Monica, alleging that police officers in the community were routinely harassing the local homeless population. The ACLU claimed that Santa Monica did not provide ample sleeping quarters at their homeless shelters, and that the city would jail anyone found sleeping in public places. The ACLU also claimed that the city treated homeless people like criminals. Recently, a U.S. District Court Judge, Hon. George H. Wu, dismissed the case with prejudice, effectively barring the ACLU from taking further legal actions on the matter, unless new evidence can

be presented. Since then, a resolution agreement between the ACLU and Santa Monica was reached outside of court. No laws or ordinances have been altered in any way. Both parties agree that homelessness is not a crime and that shelter beds should be provided as often as possible.

The ACLU has sued two other California cities, Laguna Beach and Santa Barbara, for similar reasons. All three lawsuits have been filed in the past two years. Laguna Beach police officers are now prohibited from citing and arresting people for sleeping in public places. Both Laguna Beach and Santa Barbara have been looking for ways to provide more shelter beds and services for the homeless.

CITY ENFORCES NO-BLOW POLICY - By Nathan Rodgers –

SANTA MONICA—Ordinance number 1578CCS was adopted by Santa Monica in March 1991, effectively banning all leaf blowers in the city. Yet most residents of the beach-side community plead ignorance of this law when confronted by police about leaf blower infractions. In a March 2010 report from Officer Adam Gwartz, he states that in a period of just over two hours, he and his fellow officers issued nine citations and one warning.

Certain Santa Monica residents have become so disgruntled with the use of leaf blowers that, even with leaf blower laws in place, they saw the need to begin an antileaf blower website at stopleafblowers.com. The site allows residents to report the time and location of leaf blower-uses in the community, in hopes that law-enforcement will use the information to catch leaf blowing gardeners in the act.

Santa Monica means business when it comes to leaf blowers: the official municipal code bans all leaf blowers, even electric



ones. In the most severe violations, leafblowing citizens may be charged with a misdemeanor punishable by a fine of up to \$1.000 or imprisonment in the County Jail for up to six months.

The most common complaints about leaf blowers are that they are noisy, they kick dust and debris into the air and the gaspowered ones create air pollution - adding even more smog to the city. Communities throughout the U.S. are also placing restrictions on leaf blowers. Other cities may allow blowers at selected times of the day, or they may allow electric blowers only.

The leaf blower issue is still a topic of discussion at Santa Monica City Council meetings. At their most recent gathering. Councilmember Kevin McKeown suggested adding a staff position to the city's Office of Sustainability and the Environment, and shifting the responsibility of leaf blower law enforcement to that position. and away from the city's police officers. In doing so, he believes the law may be more effectively applied.

out incident. Park appeared in court on Monday. June 21, in connection to Redding's murder. Park allegedly entered the victim's apartment on March 15, 2008, on the 1500 block of Centinela Avenue and physically assaulted her, resulting in her death. Her bail has been set at \$1 million and she faces a maximum prison term of 25 years to life if she is convicted.

Canyon News spoke to Shiara Davila of the Los Angeles County District Attorney's Office about the case. When asked by Canyon News the exact cause of death of Juliana Redding she indicated that no facts of evidence regarding the case could be discussed. "The other suspect in the case hasn't been charged at the moment because the case is under further investigation by the Santa Monica Police Department," added Davila.

Juliana was born in Tucson, Ariz. and moved to California to pursue a career in modeling and acting. She had been taking several college courses in the area, while working at a bar

FORMER HOST BANNED FROM EMPIRE STATE BUILDING - By Rosana Clarkson

MALIBU-Jeb Corliss, famous thrill seeker and former television host of "Stunt Junkies," on the Discovery Channel, has been ordered by the Manhattan Supreme Court to permanently avoid entering the premises of the Empire State Building, which he had attempted to parachute from in 2006.

The 34-year-old Malibu resident, who has made a series of successful stunt jumps from

the SMPD about the case. "The cause of death for the victim is a part of our ongoing investigation. I can't confirm that the victim was killed by blunt force trauma," said Sgt. Trisler. When asked by Canvon News if either suspect had a prior criminal record he stated "Ms. Park did not, but Mr. Case did."

"A motive has not vet been established in the death of Juliana Redding. That's a part of our ongoing investigation and it hasn't been disclosed," said Sgt. Trisler. He informed Canyon News that there are no new developments in the case and that Park is expected back in court on June 28. He indicated that Case has been released. "We potentially believe other suspects are involved," said Sgt. Trisler.

On Thursday, June 17, Lee was indicted by the US Attorney in the Southern District of Ohio Eastern Division on two counts of possession and intent to distribute. Each crime is punishable by at least five and up to 40 years of imprisonment as well as a fine of up to two million dollars. Her associates, who identified themselves as employees of Miss Lee's, have yet to be charged.

When arrested. Lee claimed that she was innocent and that, though she had planned the trip and three previous trips as well, she believed she was transporting equipment for a horse farm in Ohio owned by a friend of a friend. She also told police that she was the heiress of the Samsung fortune, though the following day the Samsung Company issued a statement refuting her claims.





Edith often said that she became an "accidental celebrity" when she was photographed by Alfred Eisenstadt as she was kissed by a joyous sailor in Times Square on the day World War II ended on August 14, 1945, a photo that appeared on the cover of Life magazine and quickly became an iconic image recognized around the world.

INTERVIEW WITH MARILYN MONROE PHOTOGRAPHER BILL CARROLL

Marilvn Monroe? A: "I knew her when she was Norma Jeane. I didn't have to do too much I would just push the camera button. The

pictures that I took were her pictures, not my creation." Q: Are there any celebrities today you'd

love to photograph?

A: "I do very little photography today. I am continuing a long-time career in book publishing."

Q: Is there anything you can tell us about Marilyn Monroe people would be surprised to hear about?

A: "I never saw Marilyn Monroe or pictures when she became an actress, I knew her as Norma Jeane.'

Q: When you're getting ready to photograph a person what's the first thing that pops into your mind?

A: "Get in that person's head. I tell them my objections, what I want to create and the use the picture will be to the public. I must be on the same track as the participant or we won't get good pictures." Q: What do you consider the most valuable piece of art?

A: "The message that it creates on the observer, whether it is an emotional or intellectual response."

Q: What's the secret to living a long and healthy life?

A: (Laughing) "It came with right genes. My mother lived to be 100. I stay active and busy and these things work."

Q: If you weren't a photographer, what career path would you have chosen?

A: "I have had more careers than many can imagine. I worked as a journalist; I worked at a bus company in management as well as book publishing."

Q: Can you describe one photograph that you saw during your lifetime that stirred strong emotion in you?

A: "A picture of the Berlin Wall where people were standing and looking at it and hoping it would come down."

Q: You took one of the very first portraits of Marilyn Monroe when she was Norma Jeane. Did vou know back then she would become this huge star?

A: "No idea at all. I was trying to take pictures of a girl next door. I had no idea



Sports _____ **BRUIN SOCCER ALUMS HELP US ADVANCE IN THE WORLD CUP**

WESTWOOD—At around 9 a.m. on June 23. the US National team had finished off a dramatic victory over Algeria in the World Cup to move on to the knockout stages, but for UCLA the win was just a little bit sweeter because of three Bruin alums who saw significant playing time during the match.

Carlos Bocanegra, who played from 1997 until 1999, is one of the team captains for the US and made his third consecutive start against Algeria. Jonathan Bornstein played from 2004 to 2005 and was seeing his first action in the World Cup at his position of left back. Bornstein played extremely well in his debut, keeping the Algerians from scoring and allowing the match to remain tied at zero until Landon Donovan was able to finally put the ball in the back of the net during the 91st minute. Benny Feilhaber was a teammate of Bornstein for one season during his time at UCLA from 2003 to 2004 and almost got a goal himself in the 65th minute. After making a nice break towards the goal, Feilhaber was heading out of bounds and attempted to make a cross to teammate Jozy Altadore. The ball ricocheted off of Algerian goalkeeper Rais Bolihi and just missed going into the net for a goal.

Feilhaber came into the game at the start of the second half and gave the US many great opportunities to take the lead. Time and time again the US made great penetration into the Algerian defense, but continued to botch all the chances they made for themselves. The US suffered another heartbreak in the first half after a goal by Clint Dempsey was disallowed because he seemed to be offside. Replays showed that Dempsey was clearly onside and the controversial call by the referee was a flashback to the game the US played against Slovenia just a few days before. Down 2-0 to Slovenia the US came back to score three straight goals in the second half to get the win. but an atrocious offside call nullified the third goal, giving the US only one point for the tie and needing a win against Algeria after England won its match against Slovenia earlier in

the day.

The US was dangerously close to not getting that win, but Landon Donovan refused to let that be the case. Heading into stoppage time, the US was playing what could have been its last four minutes of the 2010 World Cup in South Africa. TROUBLE ON OILED WATERS

WASHINGTON, D.C.—At most times and in some circumstances presidential speeches carry weight far beyond the actual words spoken or written. A president's verbal gaff can start a war, rather than prevent one. A slight mistake by a president can cause American, or even international, markets to collapse rather than stabilize.

There is a second point of great importance. Even if a president uses the best words and concepts to address any issue or crisis, those who hear those words - Americans or foreigners, friends or foe – must take his statements seriously. To be effective, a president must be believable, at least to most of the people whom he seeks to influence with his comments.

With those points in mind, we turn to President Obama's speech Tuesday night from the Oval Office on the subject of the oil spill in the Gulf of Mexico.

The main purpose of President Obama in this speech was to demonstrate he is "in charge" of the situation. He spoke on June 16. The Deepwater Horizon exploded, burned and sank two months before, on April 20. Between then and now, more oil leaked into the Gulf of Mexico than from the Exxon Valdez in Prince William Sound, Alaska, in 1989.

Obama said in his speech that "just after

the rig sank. [he assembled] a team of our nation's best scientists and engineers to tackle this challenge." Competent searchers on the Internet can easily find out that Obama did NOT assemble the best minds until much later, and when he did, he falsified their recommendations and shut down other rigs in the Gulf on his own initiative for six months.

Obama continues. "As a result of these efforts, we've directed BP to mobilize..." The Administration did no such thing. It left BP to act on its own trying to cap or stop the oil flow. The Administration did act to prevent up to a thousand oil skimmers, some from overseas, from coming to the Gulf. Obama only marginally recognizes that there are two different and independent crises demanding attention. One is plugging the leaks from the well and the other is stopping the leaked oil from destroying the fishing and tourism industries of four American states, which are also suppliers of both seafood and petroleum products to all of America.

Obama said, "We will fight this spill with everything we've got for as long as it takes." Since it is a simple matter to find out that the Administration actually hampered state and industry efforts to deal with the spreading oil, this comment backfires. The logical conclusion is that Obama did not act originally and lied about it, so in the future he will offer more of the same.

He refers to thousands of workers, thousands of troops, millions of feet of booms. If the effort were that massive and consistent. there would not have been a Coast Guard shutdown, early this week, of six oil skimmers outfitted and put into service by Governor Jindal of Louisiana.

If your house is burning down, and the Fire Department is there with hoses running, whose fault is it if the Water Department shows up and shuts them down to inspect their hoses and test the water? It is not the fault of the bureaucrats at the Water Department

I've worked in government at two levels: local and federal. I have no reason to think state government is much different. Governments are composed primarily of bureaucrats who do things by the book, come what may. When bureaucrats do exceptionally stupid things in a crisis, the fault is not theirs. The fault lies with their political leaders who have failed to change the mission and state the urgency. The fault lies with mayors, governors, or presidents who have allowed the bureaucrats to grind on in the same old ways. Obama goes on to say that BP will have to

pay for all the damages. Of course it will, just

like Exxon and the Valdez pollution. But then he talks about meeting with the Chairman of BP, and a special fund. The president of the US has no personal jurisdiction over any corporation, much less a foreign one. Did he in the private meetings at the White House threaten BP executives with criminal prosecution, loss of drilling and supply contracts, etc., unless they agreed to create the \$20 billion fund?

When a public official threatens any person or group with harmful government actions, unless the target agrees to turn over "things of value," that is called "extortion." I do not expect Obama to be prosecuted for extortion, certainly not while Eric Holder is in charge of the Department of (In)Justice. But anyone interested in whether the current US Administration is acting either competently or honestly might want to reread the federal extortion statutes and some of the cases decided under those statutes.

I'll skip for now the stacked Commission Obama has just created. I'll ignore the fact that Cap and Trade has nothing to do with the Gulf spill and will make things worse, not better, in the future. Ben Franklin first discovered the mechanics of oil calming sea waters. Barack Obama has just demonstrated the opposite. Pour the wrong words on oiled waters, and troubles get larger, not smaller.

Just a year since his demise, the media empire of Michael Jackson has generated deals that are estimated to be worth an "are you ready" figure of \$756 million. It's incredible that dead celebrities earn so much money. According to Forbes magazine's annual list of "Top Earning Dead Celebrities," last year he ranked at No. 3, with a take of \$90 million. It will be interesting to see how he will rank this year when the list comes out in October. Now \$90 million doesn't seem like a lot, but it was just three months following his demise. The monies include CD sales, the movie "This Is It" and DVD and Blu-ray sales of "This Is It."

One of the interesting mentions of the piece of Michael Jackson's pie includes Jackson's 50 percent stake in the Sony/ATV catalogue, which contains the rights to songs from the "Fab 4" the Beatles to Taylor Swift. The catalogue rakes in about \$80 million a year, according to published reports. To add in more moolah, the Jackson estate also owns most of Mijac Publishing. It is believed that the \$756 million does not include merchandising. A new Sony deal also funnels money to the estate for years' worth of future releases and projects. Jackson's posthumous money bags will most certainly keep him on Forbes's list of top-earning dead celebs.
