

Declaration of Principles







MALIBU—A 19-vear-old Malibu resident died on August 10 while in Sequoia National Park.

According to a news release from the California National Park Service, Kevin Trevor Rodriguez, 19, was declared dead at 4 p.m. on August 10 after falling more than 50 feet and "sustaining head injuries," which ultimately proved to be fatal.

According to park officials, CPR was performed on Rodriguez "for approximately 45 minutes" until park paramedics arrived and "attempted an additional 15 minutes of CPR," but Rodriguez was pronounced dead.

Rodriguez was with at least one companion when it is believed by officials that he accidentally slipped while on a vertical descent, when attempting to use smoother, more slipperv rocks to grip while climbing.

According to the statement from the NPS, "Instead of climbing down in the same location as they had ascended, they [Rodriguez and his companion(s)] attempted to descend via what appeared to be an easier route. While less steep, the rocks they chose to descend were made slippery by water passing over them during normal high water, and

The NPS warns that hazards are ever present in the park, that "rocks roll, trees topple" and "changing weather can pose dangers. People may create hazards through campfires, traffic, snowplay, and poor decisions.." Park authorities also caution that injuries and death "occur often when a down-climb is more difficult or impossible than it appeared from the ground. Visitors are warned to use extreme caution when scrambling or climb-


Viner was living in Beverly Hills at the time of his passing.





The main reason Carroll gets so much out of his players is the competitiveness he instills in them. They compete just as hard in practice, against each other, for each other's position, as they do in games. How does he get them to do this? They won't just get beat out by the guy ahead of them on the depth chart; they'll get bypassed by the guys behind them on the depth chart. It starts from the moment they set foot on campus. It's probably the main staple of his program.

> Probably the biggest factor to help Carroll's cause is the Matt Cassel Effect. Cassel, who prepped at Chatsworth, never started a game for the Trojans, yet he is now a bona fide starter in the NFL fresh off signing a huge contract with the Kansas City Chiefs. This has to be a huge motivational tool for Carroll that keeps his reserves competing against and pushing the starters hard all season long. The result: more competitive practices make Saturday afternoons in Eugene or Corvallis easier to handle. Not only does it make the team better in the long run

Take backup guarterback Mitch Mustain, for example, he was one of the highest rated quarterbacks in the country coming out of high school four years ago. Greatness was expected from the moment he chose Arkansas. Now he is battling for playing time that has yet to materialize at USC. Whether he ever gets quality playing time for the Trojans or not, you can bet he has studied the Cassel model and won't disrupt the team knowing he could still get a shot at the pros whether he plays a down this year or not. The same goes for every other position—players know that being second or third string at USC doesn't necessarily mean there won't be a pro career in the future. The other benefit of this is that should a reserve suddenly get called on for extensive duty he is prepared to succeed because his practice habits have not diminished while being further down the depth chart than he would have liked.







The nuts ... are gathered in large quantities by the Digger Indians for food. They are about as large and hard-shelled as hazelnuts,-food and fire fit for the gods from the same fruit."

Many sources suggest that the Digger Pine got its name from the Gold Miners in the northern reaches of the tree's habitant. In fact, Southern Paiute Indians were often called "Diggers" because they subsisted on root digging. It was among these Paiutes

that the "Ghost Dance" first appeared in 1870. The Native American prophet and dreamer Wovoka announced the imminent return of the dead (meaning ghosts), the ousting of the whites and the restoration of Indian lands, food supplies, and way of life; all of which would be hastened by dances and songs revealed in Wovoka's spiritual visions. The Ghost Dance spread rapidly. Its heyday coincided with the in the massacre at Wounded Knee, where the "ghost shirts" failed to protect the Sioux as promised by Wovoka.
